The National Testing Agency has been entrusted by the NCTE (National Council for Teacher Education) with the responsibility of conducting the National Common Entrance Test (NCET) for admission to **4-Year Integrated Teacher Education Programme (ITEP)** in **selected Central/State Universities/Institutions including IITs, NITs, RIEs, and Government Colleges etc. for the Academic Session 2026-27.**

2. The ITEP is a Dual Major Programme - the first major is in Education with School Specific Stage specialization and the second major is in an opted discipline.
3. National Common Entrance Test (NCET) 2026 will be conducted in 13 mediums across India in Computer Based Test (CBT) mode for the Academic Session 2026-27 as per the details given below:


